# Temporary Construction and Right of Entry License Agreement for the AVC

Gordon Dillon presented the draft license agreement for the Haynes Creek property belonging to the ROY Group. This license agreement will allow for temporary access and construction of the Crowley Reach 1 segment of the AVC until the ROY Group Authority has been formed. The license has a duration of five years and it is necessary to have before this reach of the AVC trunkline can be advertised for construction. After the ROY Group Authority is formed, a permanent easement will be negotiated. Mr. Dillon made a suggested motion, "I move the Resource and Engineering Planning Committee recommend the SECWCD Board to approve and sign a substantially similar Temporary Construction and Right of Entry License Agreement for the Arkansas Valley Conduit Fryingpan-Arkansas Project, for the Haynes Creek property." Tom Goodwin moved and Pat Edelmann seconded the motion. The motion was approved.
