

**ISSUE SUMMARY DESCRIPTION:**



**Excess Capacity Master Contract (Contract):**

The Contract was signed in 2016 and allows the District to store up to 29,938 acre-feet (AF) of water in Pueblo Reservoir on behalf of participants for 40 years. In 2022, out of the 16 participants, only 11 of those are currently storing water. Another 21 participants will join as the Arkansas Valley Conduit (AVC) is completed.

**Excess Capacity Master Contract  
June 16, 2022**

As of May 31, 2022, 3,052 AF of water were stored under the Contract, an increase of nearly 500 AF from May 1, 2022. The average storage for the year has been 2,599 acre-feet. The high point was May 31, 2022, when 3,052 AF were stored. The low point was 2,361 AF on March 10, 2022.

The Lower Arkansas Valley Water Conservancy District added about 300 AF; Security, 130 AF; Penrose, 120 AF; Stratmoor Hills, 50 AF; and Salida, 50 AF. Widefield released 140 AF; and St. Charles Mesa released 30 AF. Other accounts saw only minor fluctuations in storage amounts.
